Expense Report- $\$ 36,597.10$ is the balance in all accounts, $\$ 24,238.11$ in checking and $\$ 12,358.99$ in savings ( $\$ 8000$ is from the AZYP Grant). Balance of available funds is $\$ 28,597.10$. Expenses for the month of $\$ 5931.30$ and income of $\$ 3036.20$. <br> ii. | V. | Business Of the Organization 10:15-11:00 <br> i. Discussion/Vote- Senior Center- Jessie- The senior center is being remodeled and they need to have a place to be able to use for their card games on Tuesday the $16^{\text {th }}$ and $23^{\text {rd }}$, and on Wednesday the $17^{\text {th }}$ and $24^{\text {th }}$. The interior of the building should be done by the end of May so they can move back to the center. Motion to approve the use of the community center for the senior center to use at no cost for their activities on Tuesday and Wednesdays- Don Burch, Taylor Bowser 2 ${ }^{\text {nd }}$, All in favor. |

ii. Discussion- Athletics Department- Jessie- The athletics department at the school could use some funds so I would like to be able to have them earn some money at the cook-off to assist with their funding. I am trying to get a dunk tank for them to use to raise some money.
iii. Discussion- Chili Cook-Off- Jessie- Everything is in place for the cook-off. We have 3 live bands preforming, we will have canopies for shade that will be weighed down with water barrels, we have 9 different contestants for the tasting, numerous vendors and food vendors. Working on volunteers and am offering a $\$ 10$ gift towards food at the cook-off for your help volunteering.
iv. Discussion/Vote- Cemetery- Don Vic- The fencing material has been ordered for the community garden. We will need volunteers to help put up the fencing. There is a container that is there to hold the items needed for the garden and the cemetery afterwards. Would like SMRC to donate $20 \%$ of the cost of a water meter towards it. The total cost is $\$ 6400$. $20 \%$ of that is $\$ 1281.60$. Would also like to make the cemetery into an association. Being an association will simplify a lot of things going forward. The cost is $\$ 10$ for a lifetime membership. Motion to approve joining the association- John David, Ruthie Wentworth $2^{\text {nd }}$, all in favor. Motion to approve $\$ 1300$ towards the cost of the water meter- Jessie David, Taylor Bowser $2^{\text {nd }}$, All in favor. v. Discussion/Vote- Summer Youth Conference- Kennedy- AZYP has done a summer youth conference at the community center for the last 2 years and they want to do it again this year. They would like to do it on June $21^{\text {st }}$ from 9 to 4 pm . They are going to try to bring people from Marana so it will be easier for the volunteers to get here. Motion to approve the summer youth conference on June $21^{\text {st }}$ - Heather Fuller, Sharon Mathews $2^{\text {nd }}$, All in favor.
vi. Discussion/Vote- AA Meetings- Kennedy- We have a person based out of Mammoth that would like to start up the AA Meetings again. They have experience in starting them and running them because they have done it a few times in California. Because of how it was with the last meetings, let's do it twice a month and in 6 months review it to see if it is beneficial to the community.
